- The redemption will be processed for value on the business day TPT Wealth receives and accepts the valid instruction.
- The investment will be processed when funds from the redemption are confirmed and available for investment. Accordingly, there may be a slight timing mismatch between the redemption and investment.
- If a switch causes your investment in a Fund to fall below the minimum remaining investment balance as set out in the Fund's PDS, TPT Wealth reserves the right to reject your request or switch your full investment in that Fund.
- If you are switching into a Fund in which you are not already invested, we may be required to complete additional identification verification prior to processing your instructions.
